NEW METER & SERVICE INSTALLATION CHARGE

Whenever a new or existing customer requires service at a new location where New Mexico Water Service Company must install service line and meter facilities, the following charge shall be made for such installation:

Sierra County	\$320.00
Valencia County	\$410.00

If a service line, for whatever reason, exists but no meter installation has been performed, the customer shall pay the actual cost of the meter and meter installation but in no instance shall such charge exceed the amounts indicated above.

CONNECTION FEE

Each new or existing customer, as defined above, shall be required to pay a connection fee to cover the costs of establishing a new customer account:

MISCELLANEOUS FEES

DISCONNECT FEE: \$50.00

A disconnect fee shall be charged in each instance where a customer, either voluntarily or involuntarily, is disconnected from and, for any period, no longer receives water service from New Mexico Water Service Company.

RECONNECTION FEE: \$50.00

A reconnection fee shall be charged to each customer, who has been disconnected as defined above, and who is subsequently reconnected within less than twelve (12) months after such a disconnection.

TRANSFER FEE: \$25.00


A transfer fee shall be charged whenever an existing customer moves his water service to a new location where a service line and meter installation exists within the territories of New Mexico Water Service Company to cover the costs of establishing a new customer account.

CREDIT/DEBIT CARD TRANSACTION FEES:

If a customer requests to make payment by credit or debit card, the applicable transaction fee charged by the credit/debit card will be added to the payment at the time of payment.
