TERRITORY:

RECONNECTION CHARGE:

If a customer makes application to the Company to restore service which was previously disconnected at the same premise, less than 12 months before the date of the application for reconnection, the Company is authorized to charge a service fee of \$25.

METER TESTING CHARGE:

Upon request by a customer, the Company shall make a test of the meter serving him and shall advise the customer that he may be present. If the meter has been tested within the last twelve months, the Company may charge the customer \$25.00 for making such a test and such charge will be refunded to the customer whenever the meter proves to be in excess of two percent (2%) in error against the customer.

RETURNED CHECK CHARGE:

The Company is authorized to charge a fee of \$25.00 for each check that is returned unpaid by the customer's financial institution.

MONTHLY MINIMUM:

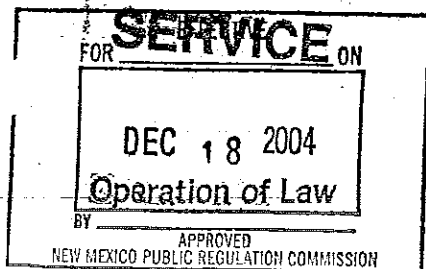



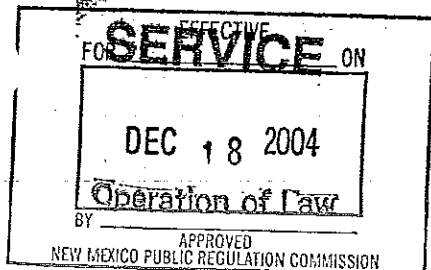
