**RECONNECTION CHARGE:**

If a customer makes application to the Company to restore sewer service which was previously disconnected at the same premise, less than 12 months before the date of the application for reconnection, the Company is authorized to charge a service fee of \$150.

**SEWER SERVICE LOCATION AND INSPECTION CHARGE:**

A charge of \$15 will be made for the location of the point of service and the required inspection of the connection between the Company's service (lateral) and the customer's yard line.

**CREDIT/DEBIT CARD TRANSACTION FEES:**

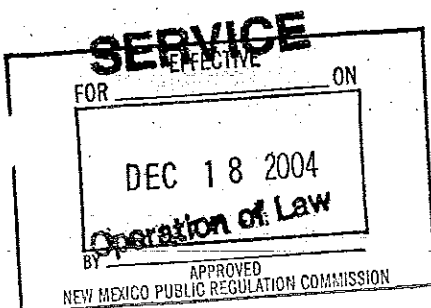
If a customer requests to make payment by credit or debit card, the applicable transaction fee charged by the credit/debit card will be added to the payment at the time of payment. X
